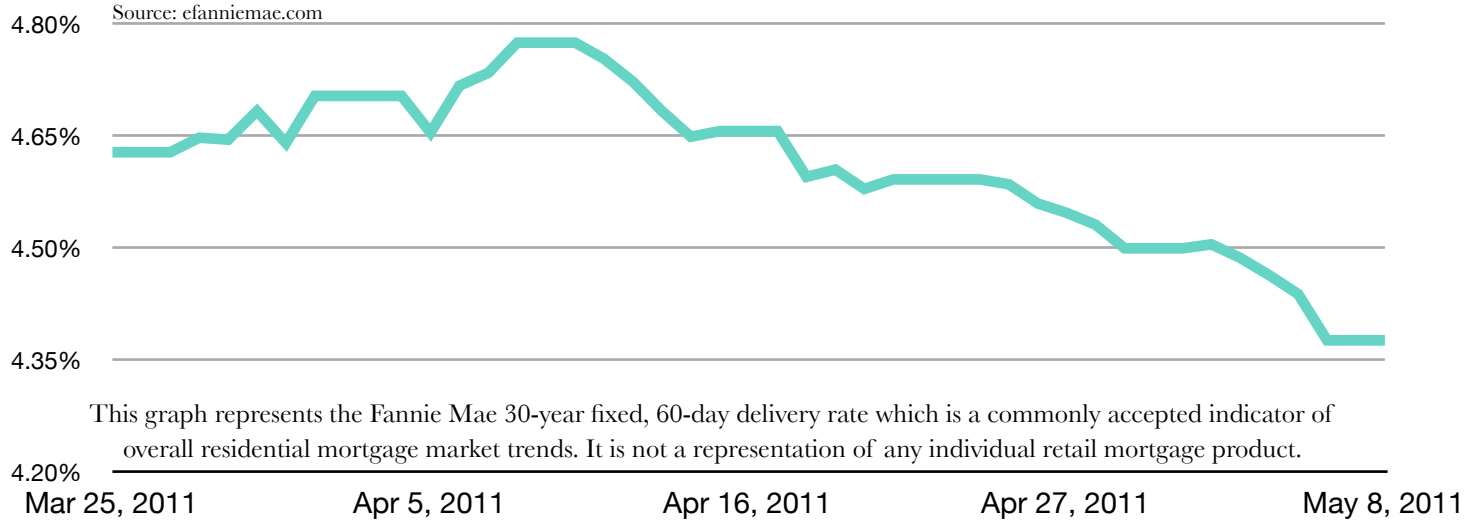

UP: 33%



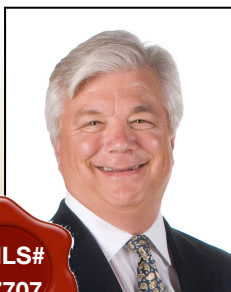
UNCHANGED:
